

## **End of Season Contract Terms & Conditions 2023**

## Offer 1

- 1. For product purchased (ordered and paid for) before 28<sup>th</sup> June 2023.
- 2. Product in this offer must be collected from Whitfert storage from 1st July 2023 and before 31st July 2024.
- 3. Product ordered must be collected from Whitfert storage before the same product can be collected under any other Whitfert 2023/24 Fertilizer Contract.
- 4. Product which has not been collected by the dates stated in paragraph 2 above will be returned to Whitfert's stock and monies paid for that product in June 2023 will be credited to the customer's account less a 15% Administration and Restocking Fee.
- 5. The offer is available on most of Whitfert's product range, although some products may be restricted on first come first served basis due to limited quantities. Whitfert will advise customers at the time of order discussion whether product restrictions apply to the product requested.
- 6. The sales contract is on a fixed price basis irrespective of whether international prices move up or down during the 2023/24 season. In all other respects the sales contract is subject to Whitfert's General Terms and Conditions of Sale (refer <a href="https://www.whitfert.com.au/images/terms-conditions/2023">https://www.whitfert.com.au/images/terms-conditions/2023</a> Terms Conditions Sale Whitfert.pdf).
- 7. If the customer chooses a 10% deposit option as payment, then the 10% deposit must be paid prior to 28<sup>th</sup> June 2023. The sum payable will be <u>10% of the total invoice value including GST</u>. The outstanding balance will be due and payable no later than 25<sup>th</sup> January 2024, or on collection if prior to this date.
- 8. Orders will be confirmed if payment is made by 28<sup>th</sup> June 2023.
- 9. Product is invoiced before 30<sup>th</sup> June 2023 and as such is owned by the customer and held in storage by Whitfert.
- 10. No product changes or refunds are available after 30<sup>th</sup> June 2023 and product must be collected before the dates outlined in paragraph 2 above. Late collection may incur a storage fee.
- 11. No other discount offers can be used in conjunction with this offer.
- 12. This offer is not open to resellers or buying groups.
- 13. The purchase price includes product insurance up until the product has been collected from Whitfert storage.
- 14. All credit payment types require Whitfert credit approval.

## Offer 2

- 1. Pre-pay a lump sum amount into your Whitfert Fertilisers account before the 28<sup>th</sup> June 2023, up to a maximum amount of AUD\$1.5 million per Whitfert Fertilisers account. The pre-payment will be invoiced as "EOFY 2023 Pre-paid Fertilizer" prior to 30<sup>th</sup> June 2023.
- 2. Pre-paid funds will need to be paid in full. A deposit option is not available under Offer 2.
- 3. No cash refunds will be available. Funds will be held in your Whitfert Fertilisers account and must be used for fertilizer purchases only.
- 4. Pre-paid funds can only be used for collections between 1<sup>st</sup> October 2023 and 30<sup>th</sup> June 2024.
- 5. Monies paid to Whitfert as a part of this 2023 Pre-Pay Now Nominate Later offer will qualify for a reward as set out below. The reward amount is not interest.
- 6. Customers will be entitled to receive a reward amount calculated daily at an annual percentage rate of 5.0% on the funds that are held in your Whitfert Fertilisers account at that time during the period 1<sup>st</sup> July 2023, until 25<sup>th</sup> February 2024.
- 7. The reward is calculated on a daily basis on the balance of the pre-paid funds only and will be credited to your Whitfert Fertilisers account on 15<sup>th</sup> April 2024.
- 8. Reward amounts are not redeemable for cash and must be used for the purchase of fertilizer from Whitfert. If you do not use all of the reward amount, the unused funds will remain in your Whitfert Fertilisers account.
- 9. The pre-paid funds cannot be used against invoices issued by Whitfert prior to the pre-payment. Payment of invoices issued prior to this Pre-Pay Now Nominate Later offer are not subject to the offer and are not eligible for a reward.
- 10. Pre-paid fertilizer purchases must have products nominated no later than the month prior to the requested collection month.
- 11. Any product remaining on a Variable order will be converted to a Fixed Price order no later than one month prior to the nominated collection month.
